- The title 'A Fur Coat' represents success, an elevated social class and conformity. Molly makes reference to other women such as deValera and General Mulcahy. She feels she has to conform to the standards set by these women.
- The fur coat would provide a sense of comfort after years of hardship.
- Literally, the fur coat is a source of warmth during cold winter days and figuratively, the warmth/love that Paddy provides by buying a fur coat as her husband.

- The fur coat is a symbol of cruelty to animals.
- It is a source of division between the 'haves' and the 'have nots'.
- It emphasises class distinction.
- It is a source of conflict between Paddy and Molly.

 The Kelvey girls are banned from associating with the other children and from seeing the dollhouse. ✓

 - Kezia is too innocent in her youth to understand the class division that predetermines the Kelveys' exclusion.
 - Kezia takes it upon herself to invite the Kelveys into the courtyard.
 - Lil, having taken on the idea of her own inferiority, knows she is not supposed to talk to Kezia or see the doll's house.
 - Lil's younger sister Else – like Kezia – is innocent enough not to understand the invisible class division that has determined her and her sister's social ostracism.
 - Even after Aunt Beryl shames the girls for thinking they could get away with talking to Kezia and entering the courtyard, Else merely thinks of Aunt Beryl as "the angry lady", not understanding why she and her sister were told to go away.
 - In her innocence, Else quickly forgets about the angry lady but remembers how she saw the little lamp – a symbol of innocence that unites her and Kezia.
- NOTE:** For full marks, the response must be well-substantiated. A candidate can score 1 or 2 marks for a response which is not well-substantiated. The candidate's interpretation must be grounded in the short story. (3)

5.2.8 Open-ended

6.1.1 Alexandra is a place where he must get love, protection and care. ✓ (1)
(Accept other suitable answers.)

6.1.2 The poem describes the social problems affecting black people during apartheid emphasised by:
The 'dongas'/ditches formed by the eroding action of rain water in Alexandra. ✓
The speaker indicates that there is dirty water mixed with blood running on the dusty streets. ✓
The water is mingled with blood, suggesting killings and death in the township. ✓
(Accept any TWO of the above.) (2)

6.1.3 'Mother' refers to Alexandra and the repetition emphasises the negative bond he has with the township. A mother is nurturing and caring while Alexandra is the opposite and makes him believe he is worthless. ✓
Alexandra is described as a 'most loving' mother. ✓ This is in contrast with how the township will be described later in the poem as being 'cruel'. ✓
(Accept any TWO of the above.) (2)

6.1.4 The speaker describes Alexandra as his mother, but when he cries of thirst she gives him dust instead of milk. ✓✓

NOTE: Both parts should be included to earn the marks. (2)

6.1.5 (a) scared/afraid/fearful ✓ (1)

(b) To indicate that the speaker feels unsafe/unprotected/vulnerable in Alexandra./He is fearful of the conditions in Alexandra. ✓ (1)

6.1.6 The exclamation mark emphasises ✓ the speaker's strong feeling of weakness. ✓ (2)

6.1.7 The speaker has tried to move away many times, but he comes back home to Alexandra – his 'mama'. ✓
When people in other countries mistreat him, he silently comes back home. ✓

NOTE: Accept any TWO of the above. (2)

6.1.8 The speaker feels he has lost his humanity and thus his confidence. ✓/The speaker feels he has been disempowered by his upbringing in Alexandra. ✓/ He feels he is not acknowledged as a human being because of his upbringing in Alexandra. ✓/ When he compares himself to others (rich/white people) and the way they are treated, he feels his humanity is not recognised. ✓ (1)

6.1.9 Open-ended

NOTE: Accept a relevant response which shows an understanding of the following aspects, **among others**:

Yes

- He cannot escape poverty or oppression; he is ashamed but cannot live anywhere else as Alexandra is his home.
- He understands how things work in Alexandra and has adapted.
- His identity is formed here, and he accepts and embraces it.
- This is where he comes from, he can just be himself here.
- He is unhappy in other countries/does not fit in and comes home.
- The fact that he has returned to Alexandra (“come back”, “waded back”) shows that he has accepted his identity.
- He came back in spite of the fact that everything is not perfect (“rubble”).
- He explicitly states that this is what he is “black”, he accepts it and comes to terms with his identity.

OR**No**

- He wants to escape but he loves Alexandra.
- His negative identity is formed here.
- He feels people use him to escape to far places/to advance in life/reach success.
- He leaves but the world is different and strange thus he silently returns.

6.2.3 The speaker compares hurtful/sarcastic/mocking words√ to acid that eats away/slowly erodes sensitivity as they are destructive/irreversible.√ (2)

6.2.4 The speaker uses these words to emphasise that harsh words are like poison√ and can cause suffering like the tongue of a poisonous snake.√/ Venomous words are like poison√ and paralyse/hurt/destroy one's self-image and relationships. √/ Serpentine tongue is a Biblical reference√ to deceit.√ The snake is the first animal reference – the poison/harsh words√ kill physically and emotionally.√

6.2.5 The use of ellipsis creates a pause/break/change in thought. √ The first four stanzas are about the effects of hurtful/destructive words and after the ellipsis the uplifting effect of positive words are stated.√ The ellipses creates a break/change√ from the negative effect that harsh, insulting words have to the uplifting effects of positive words.√

NOTE: Accept any TWO of the above (2)

6.2.6 Words should be used gently and carefully-like a soft warm jersey-loving instead of hateful√/to comfort and protect and provide warmth against the harsh/cold world.√ (2)

6.2.7 The explanation of the theme of the power of words, should include the following points, **among others**:

- Words can influence negatively or positively as determined by the tone and intention of the speaker.
- Words should be carefully chosen to comfort, otherwise they are destructive.
- Hurtful words destroy while kind words comfort.
