- Food parcels/ donations✓<sup>7</sup> were issued by the government/ schools/ NGOs/ churches/ communities.
- School feeding schemes/ nutritional programmes continued during the closure of schools.✓<sup>8</sup>
- Neighbours/ communities started supporting one another with food.✓<sup>9</sup>
- Community members started their own vegetable gardens.✓<sup>10</sup>
- Farmers continued farming even during the national lockdown.✓<sup>11</sup>

- Plain low fat yoghurt contains very little sugar/ carbohydrates/ fat✓<sup>1</sup> which will not increase blood glucose levels.✓<sup>2</sup>
- Green leafy vegetables are very low in carbohydrates✓<sup>3</sup> which help to assist with the regulation of blood glucose levels.✓<sup>4</sup>
- Brown rice has a low GI✓<sup>5</sup> and is rich in fibre✓<sup>6</sup> which improves carbohydrate metabolism✓<sup>7</sup> because glucose is released slowly into the blood.✓<sup>8</sup> This provides a steady supply of glucose instead of a sudden energy rush.✓<sup>9</sup>
- Diabetes is a risk factor for coronary heart disease.✓<sup>10</sup> Red meat is high in saturated fat/ LDL (low density lipoproteins)✓<sup>11</sup> which increases the risk of heart disease/ stroke.✓<sup>12</sup>
- Ice cream is high in sugar/ high GI,✓<sup>13</sup> which will rapidly increase/ spike the blood glucose levels.✓<sup>14</sup>
