QUESTION 1: HOW DID THE UNITED STATES OF AMERICA RESPOND TO THE DEPLOYMENT OF SOVIET MISSILES TO CUBA IN 1962?

Study Sources 1A, 1B, 1C and 1D and answer the questions that follow.

1.1 Read Source 1A.

- 1.1.1 Why, according to the source, did the American intelligence community become suspicious about events in Cuba? (1 x 2) (2)
- 1.1.2 Give the TWO steps in the source that the US government took to check what was taking place in Cuba. (2 x 1) (2)
- 1.1.3 Quote TWO pieces of evidence in the source that suggest the Soviet Union supported Cuba militarily. (2 x 1) (2)
- 1.1.4 Explain what Kennedy implied by the statement, 'this country will do whatever must be done to protect its own security and that of its allies' in the context of the deployment of Soviet missiles to Cuba. (2 x 2) (4)
- 1.1.5 Comment on why Khrushchev continued to deploy missiles to Cuba despite Kennedy's warning. (2 x 2) (4)

1.2 Use Source 1B.

- 1.2.1 Explain the concept *quarantine* in the context of the Cuban Missile Crisis. (1 x 2) (2)
- 1.2.2 Why, according to the source, did ExComm find it necessary to put pressure on the Soviet Union to remove the missiles from Cuba? (2 x 1) (2)
- 1.2.3 Using the information in the source and your own knowledge, explain why Robert McNamara and President Kennedy were determined to avoid military confrontation with the Soviet Union. (2 x 2) (4)

1.3 Study Source 1C.

- 1.3.1 Explain the messages that are conveyed in the photograph. Use the clues in the source to support your answer. (2 x 2) (4)
- 1.3.2 Comment on the usefulness of this source to a historian researching the Cuban Missile Crisis. (2 x 2) (4)

1.4 Consult Source 1D.

- 1.4.1 How, according to the source, did Khrushchev refer to the quarantine that the USA imposed on Soviet ships? (1 x 2) (2)
- 1.4.2 Select TWO pieces of evidence in the source that suggest that President Khrushchev disagreed with the quarantine that the USA intended to impose. (2 x 1) (2)
- 1.4.3 Explain what you think Khrushchev implied by the statement, 'we will not remain mere observers of pirate actions by American ships in the open sea', in the context of the Cuban Missile Crisis. (2 x 2) (4)
- 1.5 Refer to Sources 1B and 1D. Explain how the information in Source 1B differs from the evidence in Source 1D regarding the USA's decision to impose a quarantine on Soviet ships entering Cuba. (2 x 2) (4)
- 1.6 Using the information in the relevant sources and your own knowledge, write a paragraph of about EIGHT lines (about 80 words) explaining how the United States of America (USA) responded to the deployment of Soviet missiles to Cuba in 1962. (8)

QUESTION 2: HOW DID CUBA SUPPORT THE POPULAR MOVEMENT FOR THE LIBERATION OF ANGOLA (MPLA) DURING THE ANGOLAN CIVIL WAR OF 1975?

Study Sources 2A, 2B, 2C and 2D and answer the questions that follow.

2.1 Study Source 2A.

- 2.1.1 Why, according to the source, did Losada want to 'enter' Angola? (1 x 2) (2)
- 2.1.2 State the TWO requests that the MPLA made to Cuba in May 1975, as quoted in the source. (2 x 1) (2)
- 2.1.3 Explain why it was necessary for the Cubans to learn about the terrain in Angola. (2 x 2) (4)
- 2.1.4 Comment to what extent a historian would regard this source as reliable when researching the reasons for Cuba's involvement in Angola. (2 x 2) (4)

2.2 Use Source 2B.

- 2.2.1 Identify, in the source, TWO aspects of the training programme that Cuba offered Neto. (2 x 1) (2)
- 2.2.2 Name the TWO Cuban commanders in the source that were responsible for the overall operation in Angola. (2 x 1) (2)
- 2.2.3 Using the information in the source and your own knowledge, explain why Cuba decided to deploy more soldiers to Cabinda in 1975. (2 x 2) (4)

- 2.3 Refer to Sources 2A and 2B. Explain how the evidence in Source 2B supports the information in Source 2A regarding Cuba's involvement in the Angolan Civil War. (2 x 2) (4)

2.4 Read Source 2C.

- 2.4.1 Explain the concept *independence* in the context of Angola. (1 x 2) (2)
- 2.4.2 Why, according to the source, was 'Operation Carlota' launched? (1 x 2) (2)
- 2.4.3 Explain why members of the special battalion 'wore summer clothes, with no military insignia and carried briefcases and regular passports'. (2 x 2) (4)
- 2.4.4 Identify TWO military items in the source that the special battalion stored in the cargo hold of the plane. (2 x 1) (2)

2.5 Consult Source 2D.

2.5.1 Explain why this photograph was taken. (2 x 2) (4)

2.5.2 Comment on the significance of Agostinho Neto and Fidel Castro in the background of the photograph. (2 x 2) (4)

2.6 Using the information in the relevant sources and your own knowledge, write a paragraph of about EIGHT lines (about 80 words) explaining how Cuba supported the Popular Movement for the Liberation of Angola (MPLA) during the Angolan Civil War of 1975. (8)

3.1 Read Source 3A.

- 3.1.1 What, according to the source, influenced Elaine Brown's political education? (2 x 1) (2)
- 3.1.2 Quote TWO roles from the source that Elaine Brown played in the Black Panther Party. (2 x 1) (2)
- 3.1.3 Explain why Elaine Brown's appointment as the first female member of the Black Panther Party's Central Committee was significant. (1 x 2) (2)
- 3.1.4 Why, according to the source, did Elaine Brown become the leader of the Black Panther Party? (1 x 2) (2)

3.2 Consult Source 3B.

- 3.2.1 Quote TWO sentences from the source that suggest Elaine Brown took her place in African-American history. (2 x 1) (2)
- 3.2.2 Explain to what extent historians would regard Elaine Brown's leadership of the Black Panther Party as 'revolutionary'. (2 x 2) (4)
- 3.2.3 Using the information in the source and your own knowledge, explain what Elaine Brown implied by 'I would not allow my leadership to be challenged' in the context of the Black Panther Party. (2 x 2) (4)

3.3 Use Source 3C.

- 3.3.1 Comment on why this photograph was taken. (2 x 2) (4)
- 3.3.2 Explain the significance of the raised clenched fists in the photograph. (1 x 2) (2)

- 3.4 Refer to Sources 3B and 3C. Explain how the information in Source 3B supports the evidence in Source 3C regarding Elaine Brown's leadership of the Black Panther Party. (2 x 2) (4)

- 3.5.1 What, according to Elaine Brown, 'did it mean to be a Black Panther'?

- 3.5.2 Identify TWO members of the Black Panther Party in the source that were assassinated in Los Angeles in 1969.

- 3.5.4 Comment on what Elaine Brown implied by the statement, 'we wanted to be the vanguard (forerunner) for the emancipation (liberation) of African Americans ...'

- 3.5.5 Explain the limitations of this source to a historian researching the challenges that the Black Panther Party faced in the 1960s and 1970s.

- 3.6 Using the information in the relevant sources and your own knowledge, write a paragraph of about EIGHT lines (about 80 words) explaining the role that Elaine Brown played in the Black Panther Party in the 1960s and 1970s.
